 Central Medical Stores Trust (CMST) has budgeted resources and intends to apply part of the funds towards payments under Indefinite Quantity Agreements for procurement of Medical Supplies.

The Chairperson, Internal Procurement and Disposal of Assets Committee, CMST now invites sealed bids from eligible and qualified bidders for the supply and delivery of various Medical Supplies:

The Bidder must quote for the total quantities of the items offered and bids will be evaluated item by item. Qualification requirements include a minimum of two (2) years in the overall experience of the Supplier in the supply of similar goods.

- 3 Bidding will be conducted through International Competitive Bidding (ICB) procedures specified in accordance with the Public Procurement Act 2003 and Public Procurement Regulations 2004 of the Government of the Republic of Malawi.
- Interested bidders may obtain further information and inspect the Bidding Documents from the Procurement Manager address given at 9(a) below from 08.00 to 12-00 and 14.00 to 16.00 hours local time (Monday to Friday, except national public holidays).
- 5. A Bidding Document in English Language may be purchased by interested bidders from the address at 9(a) below upon payment of a non-refundable fee of MWK 10,000.00 or an equivalent of USD 14 to the address at 9(b) below. The method of payment will be Malawi Kwacha or USD, either in cash or a bank certified cheque or any other convertible currency.

- 6. Each Bidder will be required to supply the following documents or confirm their acceptance to agree to registration of themselves and the product to be supplied at the time they submit their Bid:
- a) All medical supplies must have a remaining shelf-life of at least 80% at the time of receipt by the CMST Receiving Store, National Pharmaceutical Warehouse, Lilongwe, Malawi.
- b) A sample of each medical supply, as specified in the bidding document must be provided at the same time as the Bid is submitted. Any bid submitted without the samples being supplied will be rejected as non-compliant.
- Bids must be accompanied by a Bid Security of 1% of the Total Bid Value of the item (s) contested.
 The Bid Security must be in form of a Bank Certified Cheque or Bank Guarantee issued by a reputable bank agreeable to the Purchaser.
- 8. Bids must be deposited in the Tender Box at address 9(c) below on or before 29th October 2018 at 14.00 hours local time. Electronic bidding will not be permitted and Late Bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address 9(d) below on 29th October 2018 at 14.00 hours local time.
